Of the manuscripts submitted in 2010, 13% have been accepted for publication, 23% were rejected by the editors or withdrawn by the authors. 26% of the remaining papers are under review, and 38% are still on revise and resubmit.

From the papers submitted in 2009, 35% are finally accepted and 35% finally rejected.
