Dr. Felix ACKERMANN is a Research Fellow at the German Historical Institute Warsaw. He is a historian and urban anthropologist trained in cultural and political studies at the Viadrina European University in Frankfurt (Oder) and the London School of Economics. He received his DPhil in 2008 from Viadrina with a thesis on the making of Polish, Jewish, and Belarusian ethnicities and urban space in the 20th century. An edited version was published in German as *Palimpsest Grodno* (Wiesbaden: Harrassowitz, 2010); Polish and Belarusian translations are forthcoming. In 2011–16, he taught as DAAD Visiting Associate Professor at the European Humanities University in Vilnius. His most recent publication is 'Spätes Erwachen. Prof. Dr. Korine AMACHER is Professor of Russian and Soviet History and director of the MA programme 'Russia – East Central Europe' at the University of Geneva. Her main publications focus on political and revolutionary movements in the Russian Empire, historical memory about revolutionaries and revolutions in Russia, Russian and Soviet historiography, the political uses of the past, and the (re)writing of history in contemporary Russia. She has published numerous books and articles, including *La Russie*, 1598–1917: Révoltes et mouvements révolutionnaires (Gollion: Infolio, 2012); *Histoire et mémoire dans l'espace postsoviétique: Le passé qui encombre*, with Wladimir Berelowitch (Louvain-la-Neuve: Academia, 2013); *Histoire partagée, mémoires divisées: Ukraine, Russie, Pologne*, with Éric Aunoble and Andrii Portnov (Lausanne: Antipodes, 2020).

Dr. Éric AUNOBLE is a Senior Lecturer at the University of Geneva (Department of Slavic Languages / Global Studies Institute). His field of research is the revolutionary and the early Soviet period in Ukraine, focusing on the building of Soviet institutions and culture. His work mainly deals with forms of mobilization of the poor, including of their worldview and their utopian practices. It also encompasses issues of memory induced by revolutionary turmoil. Dr. Estelle BUNOUT holds a PhD in Contemporary History from the University of Lorraine, France. For her thesis, she researched expertise on Eastern Europe in Germany and Poland (1918–72), its emergence after 1918, its formalisation as a study of the enemy, and its revision after 1945, alongside the *Ostpolitik* of Willy Brandt, until 1972. To analyze the attitude of the expert on Eastern Europe she focused on 30 experts from Germany and Poland, across the regime- and border-changes experienced by these countries, studying changes in their practice between 1918–72. For this transnational prosopography she developed a dedicated visualization, mapping together regional border changes and experts' biographical information.

Miriam KRUSE, MA, is a graduate of the interdisciplinary programme 'Culture and History of Central and Eastern Europe' at the Viadrina European University in Frankfurt (Oder), where she received her MA in 2020 with a thesis on Wehrmacht bordellos in the occupied Soviet territories during the Second World War. Her academic interests include gender history, historical politics, memory studies, nationalism, and Ukrainian history and historiography.

Dr. Živilė MIKAILIENĖ is a Researcher at the Lithuanian Institute of History in Vilnius. In 2015, she completed her doctoral dissertation, *Vilnius in the Soviet Period: Ideology and the Formation of City Identity* at the Lithuanian Institute of History and the University of Klaipėda. Her field of research reaches from the Soviet era to the history of the 21st century. Her academic interests include memory culture and memory politics in Soviet and post-Soviet Lithuania, the expression of ideology and identity in urban spaces, and youth culture during the Soviet period. Dr. Alexandr OSIPIAN is a Research Fellow at the Leibniz Institute for the History and Culture of Eastern Europe (GWZO) in Leipzig (2017-20). Other academic positions include: Visiting Professor at the Justus-Liebig-Universität in Gießen (October 2018-March 2019); Research Fellow at the National University in Kyïv (2015-17); Associate Professor of History at Kramatorsk Institute of Economics and Humanities (Kramators'k, Donets'k Oblast', Ukraine, 1994-2014). He has conducted research at George Washington University (Washington, DC), the University of California (Berkeley, CA), the Max Planck Institute for Social Anthropology (Halle, Germany), the German Historical Institute in Warsaw, and the Central European University (Budapest). He studies the discourses and practices of the construction of a usable past - history writing, public perceptions of the past, historical imagination, cultural memory - in early modern, modern and contemporary Eastern Europe. He has also examined the uses of history and memory in Ukrainian politics during electoral campaigns and in international relations with Russia and Poland, as well as their implications in the armed conflict in east Ukraine. His current work is on the economic, social, and political sources of the insurgency in the Donbas in spring 2014.

Prof. Dr. Andrii PORTNOV is Professor of the Entangled History of Ukraine at the Viadrina European University in Frankfurt (Oder), Guest Professor at the University of Potsdam, and Director of the PRISMA UKRAÏNA Research Network Eastern Europe. He holds an MA in History (2001, Dnipropetrovs'k University) and in Cultural Studies (2003, Warsaw University) and a PhD in History (2005, Ivan Krypiakevych Institute for Ukrainian Studies in L'viv). He has conducted research and lectured at the Humboldt University in Berlin, the Free University of Berlin, the Free University of Brussels, SciencesPo Lyons, the University of Basel, the University of Geneva, etc. His publications (five books and more than 200 articles) on intellectual history, memory, and genocide studies in Eastern and Central Europe have appeared in English, German, French, Polish, Russian, Ukrainian, Belarusian, Czech, Japanese, and other languages. He is currently working on a biography of the city of Dnipro(petrovs'k).

Oleksandra PROVOZIN, MA, is Researcher and Manager at the City Museum in L'viv, attached to L'viv City Council in Ukraine. She received her MA in 2016 from the Viadrina European University in Frankfurt (Oder). Her research interests focus on urban sociology with a particular emphasis on the interrelationships between city inhabitants and urban cultural heritage.

Dr. Viktoriia SERHIIENKO is a Senior Researcher at the Mykhaĭlo Hrushevs'kyĭ Institute of Ukrainian Archaeography and Source Studies of the National Academy of Sciences of Ukraine. She received her PhD in history from Taras Shevchenko National University in Kyïv (2014) and has conducted research on the 19th-20th-century religious and social history of Ukraine at the Herder Institute (Marburg, Germany) and New Europe College (Bucharest), as well as at the Universities of Warsaw and Prešov. Currently she is working on the history of Russophile and Ukrainophile orientations in eastern Slovakia between the two world wars.

Ursula WOOLLEY is a PhD candidate at the School of Slavonic and East European Studies, University College London (UCL SSEES).
