

# Functional Immunity Before the Federal Court of Justice

## I. Introduction

On 28 January 2021 the German Federal Court of Justice (FCJ) passed a widely discussed sentence against a former Afghan Soldier.<sup>1</sup> The discussion did not revolve around his crimes, but around the Court's statements on the functional immunity of foreign State officials from national criminal jurisdiction.<sup>2</sup> In this context, two aspects seem to be of greater importance for the German practice with regard to international law.

First, after analysing the current State practice and *opinio iuris*, the Court concluded that under customary international law, foreign State officials in a subordinate position do not enjoy functional immunity in national criminal proceedings for war crimes.<sup>3</sup> Since the implementation of the German Code of Crimes Against International Law (CCAIL)<sup>4</sup> in 2002, this was the first time a German court
